Membership Chair Update Stephanie Barone McKenny, PhD

The IACP Police Psychological Services Section (PPSS) is fortunate to have 198 members who hail from across the U.S. and its territories and extends internationally. Overall, we have 91 female members (46.0%) and 107 male members (54.0%).

We are so fortunate to have international members from Canada and Portugal. California—the most populous state in the U.S.—boasts the most

members (36 or 18.2%) of any region. Colorado and Florida are tied for the second most members at 14 each (or 0.1% each). There are 15 states (or 30% of the states) that have no members, and this might reflect an opportunity to be of service.

Global Affairs Committee

The IACP PPSS Global Affairs Committee was formed in 2023 and is currently chaired by **Dr. Casey Stewart** and has as its members Drs. **Ingrid Freriks, Kyle, Handley, Mini Mamak, and Pietro D'Ingillo.** The committee was initially formed to

- Broaden the focus of psychological services outside the U.S, to the larger/global law enforcement community and police psychology community
- Identify what law enforcement organizations outside the U.S lack access to psychological services/assistance and learn what those agencies and police psychologist abroad are saying they want and need.

The committee meets quarterly and has discussed a range of other areas of important focus to the global community of law enforcement and police psychologists. The committee is currently developing for global distribution to world police executives/leaders a survey asking them to describe their utilization of psychological services and identify the biggest psychological and behavioral issues/challenges facing their organizations and personnel. The survey will also ask what they think is needed on this front.

The committee is also developing for distribution a list of police psychology scholars/ researchers/practitioners across the globe for purposes of making psychology/ psychologists more accessible to police chiefs/leaders across the world.

The committee is looking to expand membership to include psychologists from places further abroad to be more representative and thus more knowledgeable and effective. We plan to bring people on in augmented fashion to create a sustainable committee. Please contact Dr. Casey Stewart if you are interested in serving on this committee.

Public Policy Committee

The public policy committee is in progress, and members have been selected. Members will be announced at IACP once confirmed. We anticipate holding our first meeting in advance of IACP. The initiatives of the committee are as follows:

Background: In recent years, states and POST boards have started to implement statutes and policies surrounding pre-employment screening and wellness visits. These statutes and policies vary significantly across states and often include language that is in direct opposition to best practices and guidelines established by professionals in our field. Further, the importance of mental health and psychological well-being among police officers has gained significant attention with the International Association of Chiefs of Police Officer Safety and Wellness symposium and initiatives. As we strive for standardized practices across states, we recognize the need for experts to contribute to policy development.

Committee Purpose: Our Committee aims to:

- Review existing state POST (Peace Officer Standards and Training) guidelines.
- Review existing state statutes.
- Propose evidence-based standards for psychological evaluations and wellness programs.
- Advocate for policies prioritizing best practice processes and officers' mental health.

Committee Member Role: Committee members will:

- Collaborate with fellow psychologists, law enforcement professionals, and legal experts.
- Shape policies that impact hiring, retention, and officers' mental health, resilience, and overall well-being.
- Influence state statutes to align with best practices.

Meetings and Commitment:

• We plan to hold monthly virtual meetings.
